Pupil Services

*The department of pupil services shall be maintained and operated to help provide for the growth and development of all pupils in accordance with the individual's needs and abilities. Through a coordinated program of the several services within the department, together with other community agencies, an effort shall be made to provide ways for knowing individual children better and to promote experiences which will assist pupils in becoming responsible individuals.*

*These services shall offer a combination of related skills, techniques, processes, and attitudes that contribute directly to changing the behavior of some children and to the educational growth of many. The department of pupil services shall provide teaching, resource, guidance and consultant services to students and staff.*

*The department of pupil services will provide home and hospital instruction, and transportation of the physically handicapped.*

Psychological Services

*Psychological consultants are available in each school to work with teachers, students and parents for the better understanding of pupils' needs and the development of programs based on these needs. They shall be available for:*

- Psychological evaluation*
- Observation and student of classroom behavior*
- Interpretation of test data*
- Liaison with physicians, psychiatrists, clinics and other agencies and the interpretation of their reports to the school*
- Arrangements for special class or school placement for pupils where the need is indicated*
- Supportive counseling for pupils and consultation with parents*
- Consultation service to secondary school counselors*

Consulting Psychiatrist

*A consulting psychiatrist shall be made available on a part-time basis for professional advice and assistance in providing:*

- Psychiatric evaluation as part of the total screening process for children with emotional problems*
- Initial psychiatric interviews, for evaluative purposes, with parents of children with emotional problems*
- Assistance in referral and follow-up procedures with outside agencies when long-term therapy is needed*
- Participation in case conferences in schools when the needs of individual children require psychiatric interpretation for the overall planning of a program to meet their needs.*

**POLICY 6430**

Instruction

Pupil Services

**The Department of Pupil Services shall develop and implement programs, procedures, and practices that provide an integrated and inclusive learning community that supports the academic achievement and the social, emotional, and behavioral development of all pupils. Through a continuum of special education programs and practices in collaboration with general education, the Pupil Services Department will provide instructional/related services and resources to prepare each student to realize their potential in accordance with their individual needs and abilities.**

**These instructional and related services and resources include the following: diagnostic evaluation, specialized instruction, social work/psychological/psychiatric services, physical/occupational therapy, speech/language therapy, guidance/school counseling, nursing/health services, homebound/hospital instruction, and transportation services. The department also provides consultations for students, staff, and families in areas such as autism, assistive/adaptive technology, psychiatric and behavioral therapy, and networking with outside agencies and service providers.**
